The Farmers Market Authority (FMA) is a state agency established to assist in the marketing of agricultural products by providing information, leadership, and modern facilities necessary to move agricultural products from the farm to the consumer. This assures the consumer a better quality product at a reasonable price and a fair return to the producer by providing a convenient, dependable place through which producers and buyers may carry on the process of marketing.

MARKET DEVELOPMENT

Communities are assisted with the start-up of new farmers markets. The growth of existing markets is supported through assistance with organizational development, grower recruitment, and volunteers as well as assisting markets in becoming self-sustaining.

TRAINING FOR MARKET MANAGERS AND VENDORS

Training seminars are conducted for market managers to improve their management and marketing skills. Assistance is offered to markets by conducting educational workshops for the farmers in their area.

FMA secures funding for the Women, Infants and Children's (WIC) and Senior Farmers Market Nutrition Programs. We encourage agencies, organizations, communities and farmers to become active partners in a common effort to support the local economy, conserve natural resources, and improve the health of families.
